

Regulations HOOSY Hackathon 2024

Participants

All participants must register in advance and can participate individually or as a team. Participants must adhere to the rules of the hackathon and behave respectfully and cooperatively towards other participants. Participants must have reached the age of 18 on the day of the event. Participation is only possible in person. The organizing committee reserves the right to reject any registration.

Registration Deadline

The deadline for registration for participation in the hackathon is March 7, 2024, at 12:00 PM.

Penalty for Non-Attendance

If a participant fails to withdraw before the start of the event or fails to communicate their inability to participate, the organizer reserves the right to impose a penalty of €500.

Cancellation of the Event

The organizer reserves the right to cancel the hackathon up to 5 days before the event without providing a reason. If the hackathon is canceled due to unforeseen circumstances or force majeure, the organizer cannot be held liable.

Event Location

The hackathon takes place as part of the Internorga at the Hamburg Messe in the Chicago Room in the conference area directly adjacent to Hall A4.

Duration

The hackathon has a fixed duration of 24 hours. Participants must develop their projects within this time frame (anything from prototype to version 1.0 is permissible).



Theme/Topics

The hackathon has a specific theme with 4 different tasks for participants to work on. Participants must develop their projects within this framework. The exact task will be communicated to all registered participants via email approximately 1 week before the event.

Presentation

After the hackathon, participants must present their projects to the jury in 5-minute elevator pitches.

Evaluation

Projects will be evaluated by a jury based on the following criteria:

- Technical Complexity and Challenge
- Professional Implementation
- Degree of Innovation

Prizes

The prize money totals €5,000 (five thousand);

1st €3,000

2nd €1,500

3rd €500

If a team wins a prize, the amount applies per team.

Equipment

Participants must bring their own computer or laptop, hard drives, chargers, and any other devices they need for their work. The organizer will provide electricity and an internet connection. If the electricity, internet connection, or any other equipment provided by the organizer does not function, the organizer cannot be held liable.

Rules and Regulations

Participants must adhere to the rules and regulations of the hackathon set by the organizers. Participants must also comply with the house rules of the Hamburg Messe/Internorga, especially during times when the fair is closed to the public. Violation of these rules will result in disqualification.

Intellectual Property

The intellectual property created during the hackathon is freely available to the participants who developed it, as well as to Hoosy, its members, and the sponsors & partners of the event, at no cost.

Ethical Conduct and Guidelines

All solutions developed must comply with moral, cultural, criminal, and civil law regulations!

Support

Participants may receive support from mentors or other participants but may not seek help from external sources unless expressly permitted.

Security and Data Protection: Participants must ensure that their projects are secure and respect the privacy and rights of others.

Changes and Additions

The organizers reserve the right to change or supplement the regulations as necessary.

GDPR

The participants data will be processed based on Art. 6 (1) (b) GDPR (contract/pre-contract) and based on Art. 6 (3) sentence 1 (b) GDPR (organizational investigations and business statistics).

As a participant in the event, we may use your data to send you information about content that may be of interest to you. The legal basis for sending is, after weighing and safeguarding our overriding legitimate interests, Art. 6 (1) lit. f GDPR in conjunction with § 7 UWG. You can object to the use at any time free of charge by notifying us in writing by email.

Furthermore, media coverage of the event may include photo and/or video recordings.

It is agreed that all usage rights to the recordings (e.g., images, videos, or other media) made during our events/training courses will be irrevocably transferred exclusively to the copyright holder (and their successors). The transfer of usage rights extends to all currently known types of use and includes reproduction, distribution, digitization, exhibition, presentation, broadcasting, public accessibility, and public performance through image/sound/data carriers. The recordings may thus be used digitally or analogically in all suitable media (e.g., online use of any kind, any print use, TV, cinema, theater, videograms (CD, DVD, etc.), interactive and multimedia use, etc.) and stored in databases, including those accessible online. The recordings may be edited or modified (e.g., assembly, combination with images, texts, or graphics, photographic alienation, coloring) while preserving the employee's personal rights at the discretion of the authorized user. This contract is subject to German law with the exclusion of conflict of laws. Side agreements do not exist. If individual provisions of this contract are invalid, the validity of the remaining contract shall not be affected.

Recipient or categories of recipients of personal data

Your personal data will be transmitted to:

- if applicable, service providers commissioned with the organization and implementation of an event,
- to third parties if we are legally obliged to do so or if you have consented to the transfer of data in advance or to institutions that are co-organizers, or if the event takes place in another company or venue, possibly for admission control
- if applicable, partners and sponsors and partners of the event

Our service providers for technical support of the application and for the supervision of the event have access to the data.
